REQUIREMENTS FOR BACHELOR'S DEGREE PROGRAMMES

- Be over the age of 18
- Have a valid St Vincent and Grenadines passport (scanned copy to be provided for online application)
- Must be available to commence programmes of studies in September / October 2021

- Must gain unconditional acceptance to the course of study for which the scholarship is sought
- Agree to reside for the duration of their course at the UWTSD Lampeter campus.
- Scholarships for the on campus undergraduate programmes cover the cost of tuition, airport transfer in the UK and accommodation on the UWTSD Lampeter campus. Awardees will be responsible for their daily living expenses, including food and recreational costs, all UK government visa fees, and incidentals. (Arrangements for the required funding can be made with the St. Vincent and the Grenadines Student Loan Company).

REQUIREMENTS FOR POSTGRADUATE PROGRAMME

All postgraduate courses will be delivered online and applicants must meet the following criteria:

- Be over the age of 18.
- Have a valid St Vincent and Grenadines passport (scanned copy to be provided for the application)
- Must be available to commence their programme of study online in September / October 2021.

- Must gain unconditional acceptance from UWTSD to the course of study for which the scholarship is sought.
- Scholarships for the online postgraduate programmes cover the cost of tuition only. Awardees will be responsible for all other expenses, including but not limited to, digital equipment required for the course.
